

## SPECIAL OLYMPICS PENNSYLVANIA “DUNK & PLUNGE” PHILADELPHIA POLAR PLUNGE CONTEST

The highest fundraiser during contest (subject to rules below) will win the Grand Prize.

### OFFICIAL CONTEST RULES

Contest opens 12:00 PM (ET) on January 18, 2023;  
and closes at 12:00 PM (ET) on February 8, 2023.

1. This contest is void where prohibited.
2. **Entry:** All cumulative fundraising by/credited to registered eligible participants in the 2023 Philadelphia Polar Plunge at <https://give.specialolympicspa.org/event/2023-special-olympics-philadelphia-polar-plunge/e418049> from January 18, 2023 at 12:00 PM (ET) through February 8, 2023 at 12:00 PM (ET) will automatically count towards Contest. All Polar Plunge registration types are eligible except for “Cool Schools” and “Student K-12.” Corporate sponsorship credit is excluded from Contest. Fundraising prior to January 18, 2023 at 12:00 PM (ET) and after February 8, 2023 at 12:00 PM (ET) is not eligible for Contest.
3. Special Olympics PA and its partners are not responsible for lost, late, illegible, mutilated, destroyed, postage due, misdirected or stolen entries, or problems of any kind whether mechanical, human or electronic, whether within or beyond the control of Special Olympics PA, its agencies or employees. No other means of Contest entry are allowed. Limit ONE entry per person. **Entries submitted in violation of the official rules, including multiple entries will be void.** All entries become the property of Special Olympics PA and will not be returned. All fundraising must be received by 12:00 PM ET on February 8, 2023, the official end date of the Contest.
4. **Eligibility:** The Contest is open only to residents of the 50 United States and the District of Columbia who are **18 years of age or older** as of date of entry. Special Olympics PA employees, its affiliated advertising/public relations’ agencies, participating sponsors/promotional partners, and the members of their immediate families are ineligible

to enter the Contest. Entrants are required to provide truthful information. **Special Olympics PA will reject and delete any entry that they discover to be false or fraudulent or to contain any incorrect statement, including without limitation, the incorrect age of the entrant or ineligible registration type.** This Contest is subject to all federal, state, provincial, and local U.S. and Canadian laws.

5. **Prize Determination:** Receiving a prize is contingent upon compliance with these Official Rules. The Grand Prize Winner and Second Prize Winner will be determined on February 8, 2023 as the top two fundraisers from all eligible registrants and eligible fundraising. The winners will be notified by phone and/or email with details on how to claim their prize. To claim a prize, prizewinner must respond within one (2) hours of notification and prizewinner must sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited). If prizewinner does not comply, the prize package will be forfeited and an alternate winner may be selected at Special Olympics PA's sole discretion. The alternate will then have one (2) hours from notification to claim the prize. Odds of winning will depend on the number of eligible participants/fundraisers during Contest.
6. **Claiming of Prize:** Winners can claim their prize by emailing a copy of their driver's license, passport, or social security card, along with a signed letter of acceptance that will be sent to the winners upon notification on February 8, 2023. Prizewinners must sign and return an Affidavit of Eligibility and Liability/Publicity Release.
7. **Prizes:** Grand Prize of two (2) Club Level tickets to the Philadelphia 76ers game on February 10, 2023, at the Wells Fargo Center and a one-night stay at the Courtyard Philadelphia Navy Yard South on February 10, 2023. Second prize of two (2) lower-level tickets to the Philadelphia 76ers game on February 15, 2023, at the Wells Fargo Center.

Prizes can only be used on only the specified event. Blackout event dates or other restrictions may apply. Pursuant to the liability/publicity release, winners will agree to hold Special Olympics Pennsylvania and its affiliated companies and the officers, shareholders, directors, employees, sponsors, vendors, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the Contest prizes or participation in the Contest. Any and all disputes, claims and causes of action arising out of or connected with this Contest, or the Contest prizes or any component of the Contest prizes awarded shall be resolved individually, without resort to any form of class action, and

exclusively by binding arbitration.
